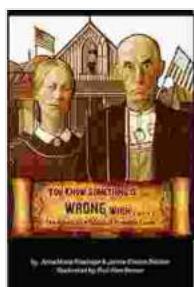

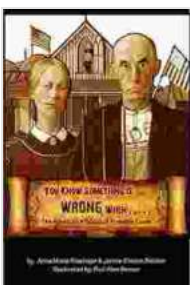

I, Bradley A. Rumsey #173, a Law Enforcement Officer with the Terre Haute Police Department, swear or affirm that on or about the 5th day of March, 2018, in Vigo County, Indiana, the above-named person committed the crime(s) of:

~~Obstruction of Justice - Level 6 Felony~~ *False Infrim*

and such belief is based on the following:  
On 03-05-2018 I was assigned to investigate the murder of Amanda J. Kerns and serious bodily injuries to Ronald Lawrence (R.D.) that had occurred at 2124 Putnam st. in Terre Haute, Indiana. While at Regional Hospital during the investigation, I was notified by Sgt. D. Lewis #95 to go to IHPD Headquarters. A man had come in and wanted to speak with Officers about the incident and was at Headquarters waiting to speak with a detective. I went to Headquarters and interviewed Terry S. Scamhorn. The interview was conducted in an interview room at Headquarters and was video and audio recorded. Mr. Scamhorn was advised of his Miranda Rights prior to the interview as well. He signed the waiver of his rights. Mr. Scamhorn advised me he had gone to the residence where the incident occurred and not been there for very long and was speaking to one of the victims in the case. He identified that victim as a man he called R.D. He claimed that he had gone to R.D.'s to discuss buying a tractor from a friend of R.D.'s in Center Point, Indiana. He said that he was in the kitchen and that he also advised me that after having been at the residence for a short time that there was a knock on the back door. He said that he was in the kitchen near the back door and was asked by R.D., who was near the dining room, to answer the door. He said that this is when a large man covered with numerous tattoos all over his arms and neck forced the door open knocking him backwards. He said that the man immediately charged at R.D. and the two had a verbal altercation. He advised that the argument was over a woman but had no information on exact content of the argument. He also said that the man whom he believes to be "Mikey" was not holding any kind of firearm at that time. He said he didn't want any part of the argument so he then left the home out the rear door. He went to his truck which had been parked behind the residence and he backed out into the alley and then shortly after going past the shed at the rear of the property he heard gun shots. He continued to leave and as he was exiting the alley at Putnam st. he saw a man flagging him down. He stopped to see what the man wanted and the asked for a rifle. He then left the area with the man and brought him to his house where the man was later picked up by an unknown person. After telling me this original version of the story he added that a third man was in the house but he didn't know who the man was.

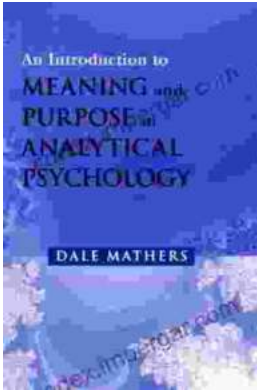

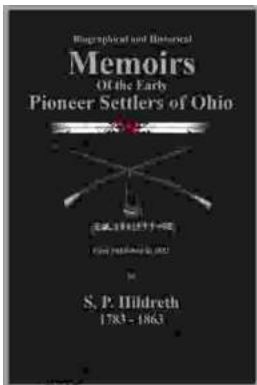
